

Hunter Primary is a non-denominational school in the East Kilbride area of South Lanarkshire, providing education to pupils in P1-7. The school is part of the Calderglen Learning Community with associated feeder primary schools Blacklaw PS, Halfmerke PS, Heathery Knowe PS, Long Calderwood PS, Maxwelton PS, Murray PS, Mount Cameron PS and Jackton PS.

### **New pupils**



In most cases arrangements will then be made to ensure a smooth transition to Hunter Primary. This may include a visit to look round and one or more short visits to the new class.

### 4. School Ethos

We encourage you to visit our school and experience the positive school ethos first hand.

We aim to motivate all children to acquire and develop the skills needed to achieve their full potential and to 'reach for the stars' in their education.

As a staff we highly value partnership with parents as the most effective way to ensuring that the school continually strives to provide education of the highest quality. We nurture every child to reach his or her potential and we celebrate both achievements within the school and within our community. We encourage all our pupils to continue to be lifelong learners and we nurture opportunities to develop a strong sense of responsibility and citizenship within and beyond school life.

The atmosphere in our school is happy, relaxed, welcoming and supportive. We have very high standards of pupil behaviour and children are guided to make positive choices within a supportive, whole school relationship policy. We promote positive behaviour and celebrate success. Pupils are rewarded for their effort and achievements increasing motivation and self-esteem.

We see the school community as an extension of the family and we aim to develop relationships in an atmosphere of trust. We take pride in the high level of care we are able to offer.

### **Celebrating Achievements**

We regularly celebrate achievements, both within and beyond the school. This motivates our children to aspire towards excellence and to have high expectations of themselves and for their teams. We encourage our children and our entire school team to be reflective, always looking to improve our efforts, performances and achievements in every area of learning and school life. We celebrate and recognise success and achievement at various levels:-

- 1. <u>Class</u> pupils' efforts are recognised and celebrated through a variety of classroom based rewards e.g. stickers, wristbands, praise notes home, house points, secret student, star of the week.
- 2. Whole school teachers are regularly asked to nominate specific pupils for a variety of rewards:

**Star Spot award** – celebration of good work, displayed in school.

**The 'Heart of Hunter' award** - Children being nominated for displaying the Hunter values and overall great citizenship.

**Playground award** - Support Staff and Davy the Janitor nominate pupils in all classes for displaying good behaviour, manners, supporting friends, helping outside, etc.

**'Hunter's Got Talent' award** – This is a new reward introduced this session to recognise and celebrate the wider achievements of our pupils out of school. Parents/carers can send in a nomination form, or the pupil can nominate themselves.

**Head Teacher award** – Awards issued to pupils for a good piece of work, effort, attitude.

**Hot Chocolate with PT** – Pupils identified by their teacher for effort will meet with Mrs. Baddeley on a Friday where they will enjoy a cup hot chocolate and cookies

### **Pupil Voice and Pupil Leadership in Hunter Primary:**

### **Pupil Council**

Each year all children have the opportunity to put themselves forward as class representative on the Pupil Council. The selection process is made democratically by ballot with two children from each class elected to serve for the school session.

The Pupil Council has a very important role in the life of the school.

### A note from our Pupil Council

In the Pupil Council our goal is to share our ideas and classmates' ideas to make the school a better place.

#### What's a Pupil Council?

A Pupil Council is an elected group of pupils that try to help the school and various charities.

### What a Pupil Council does?

We help organise charity events, keep pupils updated about what is happening and try to improve things in the school

#### **Eco Committee**

This session our new Eco Committee has been set up and are beginning to go through the accredited Eco Schools national project. Children review and implement strategies on improving our schools eco footprint, including biodiversity.

#### **Sports Committee**

Working alongside Mr. Campbell, the Sports Council's aims it to review and develop physical activity and participation within sport. This includes P.E., sporting extra-curricular opportunities, recording achievements and successes in sport in and out of school. The Sports Council will gather evidence in the hope to achieve the Gold status national Sport Scotland award. Having already achieved Silver, we are well on our way.



#### **JRSO**



The JRSO (Junior Road Safety Officers) work with Mrs. Baddeley to support Road Safety around the school grounds. Our JRSO officers hold competitions with children (Be Bright, Be Seen) and work on highlighting the importance of road safety in and around our school grounds. JRSO officers also attend the annual JRSO Roadshow which is held at the beginning of each session.

### **Reading Leaders**



We value the benefits of reading highly in Hunter Primary. Our Reading Leaders, working alongside Miss Laughland work to encourage and develop the love of 'reading for pleasure' across the school community. This session they are beginning to develop a new library resource centre within the school – including new furniture, resources, posters, etc. Reading Leaders will also work closely in collecting evidence for the Reading Schools Award.

#### **Hunter Huddle**

To ensure all pupils have a 'voice', and their opinions gathered, every child in the school takes part in a whole school 'Hunter Huddle'2, 1 per term. Focussing in on aspects within our School Improvement Plan/areas for improvement, children's views are gathered. All of which will shape the direction of change within our school.



#### **Extra-Curricular Activities**

After school activities and clubs are an important part of our school life and contribute to raising achievement and attainment. All pupils at will have the opportunity to be involved in a number of extra-curricular activities at lunchtime and the end of the school day throughout the school year. These are presently organised and supervised by members of staff together with interested parents. More parents are always welcome to assist or indeed extend the range of activities on offer.

All classes have at least one educational outing each session linked to Interdisciplinary learning work or other curricular areas. All of these activities help to broaden our pupils' experiences and enhancing the quality of their learning.

### **Hunter Primary House System**

Each child in P1-7 is a member of one house for the duration of their time at Hunter. This has been in place for some years now and is very popular with both the children and the staff. Pupils across the school in Primaries 1-7 are organised into one of the four houses:

- Bruce House (Blue)
- Burns House (Green)
- Graham Bell House (Yellow)
- Wallace House (Red)

Overseen by Mrs. Baddeley, the House Captains and Vice Captains, children across the school can gain House points for literally anything they do well that is recognised by a member of staff or visitor to the school. This includes items such as:

- ✓ A good piece of work
- ✓ Demonstrating good manners
- ✓ Good walking throughout the school
- ✓ Super lining up
- ✓ Demonstrating the Hunter values, good citizenship, and a lot more

At our weekly assemblies, House captains and vice captains will tally up total scores to date and share these with the children. On a termly basis (October holiday, before Christmas, Easter and Summer), the winning house will receive a prize.

### 4. Attendance

Every effort should be made to ensure that your child attends school during term time. Please contact the school as soon as possible if your child is unable to attend school. It is important for the school to work with parents/carers in encouraging children to attend school. All absences are required by law to be recorded. Absences will normally fall under two categories — authorised or unauthorised absence. In cases where your child is unable to attend school parents are asked to:

- If you know in advance of any reason why your child is likely to be absent from school, please tell someone at the school office, telephone us (01355 221076), or let us know in writing by email office@hunter-pri.s-lanark.sch.uk. It is important to state the specific reason for your child's absence in order for it to be authorised.
- Notify the school first thing in the morning when your child is going to be absent. Let the school know the likely date of return and keep them informed if the date changes;
- Inform the school of any change to the following:
  - o Home telephone number
  - o Mobile number
  - o Emergency contact details
- Requests for your child to be absent from school to make an extended visit to relatives must be made in writing to the Head Teacher, detailing the reason, destination and duration of absence and arrangements for their continuing education. On these occasions the pupil will be marked as an authorised absentee in the register.

Requests for your child to be absent from school to make an extended visit to relatives either in the UK or overseas must be made in writing to the head teacher, detailing the reason, destination and duration of absence and arrangements for their continuing education. On these occasions the pupil will be marked as an unauthorised absence.

Parents may request that their children be permitted to be absent in order to celebrate recognised religious events. Advance notice should be provided to the school when children will be absent. Appropriate requests will be granted, and the pupil noted as an authorised absentee in the register. (See section 7).

#### **Hospital and Dental Appointments**

Pupils must be collected from the school building for appointments, unless the requested dismissal time corresponds with the school closure time, when crossing patrols are on duty. Please inform us in advance if you will be collecting your child for an appointment.

### **Late Arrivals**

We understand that in exceptional circumstances your child may arrive late for school. It is vital that you enter school by the main entrance and report to the school office where your child's arrival will be recorded. Staff will then ensure your child arrives in class safely.

#### Hunter - A Safe School

Hunter Primary places a strong emphasis on pupil safety and parents may wish to know that an adult presence is provided in the playground at break times in terms of the Schools (Safety and Supervision of Pupils) (Scotland) Regulations 1990.

A door security entry system operates in the building. Visitors should report to the main office and sign in. At no point should any visitor go directly to a classroom.

### Information to Proposed Transfer of School

If you are proposing a change of school for your child please provide as many contact details as possible in relation to the new school so that we can ensure a smooth transfer of information relating to the child. All details regarding your child's progress will be transferred to the new school.

### Information on emergencies

We make every effort to ensure the school remains open during term-time for pupils. However, on occasions circumstances may arise which can affect the school. Schools may be affected by, for example, severe weather, power failures or through any other circumstances that may impact on the school day. In such cases we shall do all we can to let you know as soon as possible. We shall keep in touch by the most appropriate method at the time normally through text message, and via our social media channels.

In cases of severe weather in the morning such as snow and a heavy frost and if there is a reason the school cannot open in the morning at the normal time, we will adopt the protocol for a delayed start until 10am.

If this is the case a message via social media and on the council's website will be posted.

The Council's website <a href="www.southlanarkshire.gov.uk">www.southlanarkshire.gov.uk</a> will be used to let you know if the school is closed or has a delayed start. Further information will be provided later in the day as to whether the school will be open as normal the next day.

#### Things we need you to do:

- It is important for parents/carers to let the school know of any change to your mobile/home telephone number and change of address.

#### a. Your commitments

We ask that you:

- support and encourage your child's learning ask them what they have been doing.
- respect and adhere to the school's policies and guidance.
- accept your responsibility to respect staff who work in the school and for the school to be proactive in taking forward its commitment to care for and educate your child.

### Family holidays during term time

Every effort should be made to ensure that your child attends school during term time. Please contact the school as soon as possible if your child is unable to attend school.

Family holidays should be avoided during term time as this both disrupts the child's education and reduces learning time. If holidays are taken during times when the school is open parents should inform the school in advance by letter.

If your child is taken on a family holiday during term time, then in line with Scottish Government advice this will be classified as an unauthorised absence. However, in exceptional circumstances schools may register a family holiday during term time as an authorised absence when for example, parents are able to demonstrate they have been unable to obtain leave during the school holiday period.

Clearly, absence with no explanation from parents will mean that the absence will be recorded as unauthorised.

In our approach to raising attainment and achievement it is recognised that attendance at school is something that should be continuously encouraged. Parents/carers, children and the school all have a part to play in encouraging and stressing the importance of attendance at school.

### 6. Parental Involvement/Parent Council

Parents, carers and family members are by far the most important influences on children's lives. Children between the ages of 5 and 16 children spend only 15% of their time in school! Research shows that when parents are involved in their child's learning, children do better at school and throughout life. Parental involvement can take different forms but we hope you share the same aims and agree that by working together we can be partners in supporting children's learning.

As a parents/carers we want you to be:

- Welcomed and given an opportunity to be involved in the life of the school;
- Fully informed about your child's learning;
- Encouraged to make an active contribution to your child's learning;
- Able to support learning at home;
- Encouraged to express your views and involved in forums and discussions on education related issues.

Every parent with a child at school is automatically a member of our parent forum. The Parent Council is a formal group, with a constitution, and acts as the Parent Voice of the school.

Parent/community helpers are now required to complete a PVG check before being able to help in school on a regular basis. This is part of a nationwide procedure designed to safeguard our children.

Hunter Primary is involved in liaison with local Pre-5 Centres and Secondary schools and maintain useful links with other Primary school in the local area. Pupils have opportunities to visit the local community and we encourage our pupils to take pride in where they live and contribute in any way possible. We also welcome community members who are willing to share their particular expertise with our children. This is a valuable community resource and it helps build mutual respect between our children and other adults in the community. We enjoy good relationships with the local churches, School Health Service, Community Police Service and Fire Service.

Pupils are set homework from the early stages. Our aims are to reinforce processes and skills taught in school, and to establish the habit of work at home which will stand pupils in good stead in further education and in later adult life.

As part of our policy, we promote different types of homework that include not only the routine tasks but also tasks that involve thought and individual effort. Homework is given out in class on a weekly basis and we currently use Google Classroom as our main method of issuing homework. If you need any help or support with IT access, please let us know.

Classes will receive an explanation at the beginning of the school year as to the pattern of completion as this varies depending on the stage of the pupils within the school. This work will reflect current class work (generally Numeracy/maths, Reading and Spelling) or perhaps revision work prior to the beginning of a new topic/theme in class but will always have been explained to pupils in advance.

Parents and carers are asked to co-operate in the return of homework and to take an interest in the quality of work done at home. We always appreciate feedback on homework. If your child seems worried about some aspect of homework, please do not hesitate to contact the class teacher or a member of the Senior Leadership Team.

### **Hunter Primary Parent Council**

What does the Parent Council do?

The school and the local authority are obliged to listen to what the Parent Council says and to respond to the issues raised. Parent Councils decide such things as:-

Curriculum for Excellence is the name given to the curriculum in Scotland for all children and young people aged 3-18. It is a forward looking, coherent, more flexible and enriched curriculum that provides young people with opportunities to engage with the knowledge, skills and attributes they will need to flourish in life, learning and work.

The curriculum places learners at the heart of education and at its centre are four fundamental capacities - successful learners, confident individuals, responsible citizens, and effective contributors. It includes all of the experiences that are planned for children and young people to support the development of their skills, wherever they are being educated, for example in the family and community, pre-school centre, nursery, and school.

In taking this forward our school will work closely with South Lanarkshire Education Resources and other services to enrich the curriculum, to provide the best possible education for all children and young people. We wish you to feel confident that your child is encouraged and supported to develop their literacy, numeracy and other skills whilst they attend our school. The curricular areas are as follows:

- Expressive arts
- Languages and literacy
- Health and wellbeing
- Mathematics and numeracy
- Religious and moral education
- Science
- Social studies
- Technologies

### **Languages and Literacy**

Literacy encompasses Talking, Listening, Reading and Writing.


The Literacy and English framework is designed to develop critical thinking as well as competence in listening, talking, reading and writing. We also seek to develop personal, interpersonal and team working skills, through a broad range of learning opportunities.

Reading skills are taught throughout the school using a variety of resources. Our approach focuses on the variety of skills needed for reading. From Primary 1 onwards, a variety of resources are used to develop children's skills. The main resources used are Big Cat as well as a variety of novel studies. We also use IT based resources to further support and enhance reading skills. We place a strong emphasis on using 'real books' and the children are encouraged to read talk and write about their individual reading aboves from an early

read, talk and write about their individual reading choices from an early age. Each

classroom has a library and children can access our school library.

<u>Writing</u> will stem from interdisciplinary work, reading and literacy tasks as well as topical or personal interest. It will develop writing skills according to a variety of genres such as recount, report, discursive, argument, imaginative and personal.



language and literacy skills. The programme is progressive, each stage building on the work which has taken place previously and relies on a common structure being followed by all classes so that the children can maximise their learning. In the early stages the focus is on learning all phonics using a Say/Make/Break/Read and Write method in order for the child to make links within literacy.

As they move on, they are encouraged to use their phonological skills to help them to help them spell accurately as well as read with understanding and expression, thus building confidence and engaging children in their learning in an enjoyable and interactive way.

<u>Talking and Listening</u> is developed across all curricular areas. Again, interdisciplinary work will play a major part here. Skills are explicitly taught and developed.

 $\underline{\text{Modern Languages}}$  - We develop knowledge and understanding of another modern language with all stages engaging with the French language through games, songs, dance, rhymes, story telling and short plays. In addition to French, P5 – P7 are exposed to Spanish.

The French language programme concentrates on certain themes which will be beneficial to the children e.g. colours, time, days of the week, weather, part of the body, food, numbers and the alphabet.



### **Mathematics and Numeracy**

In mathematics and numeracy, the children will study the following areas:

- Number, Money and Measure
- Shape, Position and Movement
- **Problem Solving**
- Information Handling

Mathematics is important in everyday life, allowing us to make sense of the world around us.

Through a wide and varied range of learning opportunities and experiences, children develop confidence to take risks, ask questions and explore alternative solutions. They apply mathematical concepts to understand and

solve problems, explain their thinking and present their solutions to others in a variety of ways. We work through a combination of coherent, programmes, established ΙT opportunities, problem solving activities, active **learning** cross-curricular opportunities and learning experiences.

A variety of materials are used for learning and teaching concepts such as practical materials e.g. cubes, games, computer programs as well as workbooks and textbooks. Scottish Heinemann Maths and TeeJay maths are in use, and are excellent resources for teachers to use in numeracy and maths teaching.



All children in Primary 1-7 has access to the online program Sumdog – this is used for both class activities, extension, consolidation and challenge, as well as homework.

#### **Big Maths**

Big Maths is a teaching method that embraces the logical nature of maths, translating it into simple steps, with a particular focus on mental agility using number. This makes progress easy and fun for both children and teachers giving all pupils the opportunity to achieve.

#### Health and Wellbeing

We seek to promote health and wellbeing through the development of experiences and outcomes related to Physical Education, healthy eating, making choices and changes, understanding of mental, emotional, social and physical wellbeing, drug education and education related to relationships and sexual health.





At Hunter Primary, learning and health go hand in hand. Good health of pupils is a pre-requisite for educational achievement and good health of teachers is important to the development of an effective school. Over the last few years the issues surrounding the health of pupils in Scottish schools have become an increasingly prominent part of national agendas for improvement. Part of this agenda is to provide a minimum of two hours PE

for every child. This target is met by every Hunter Primary pupil.

The experiences and outcomes reflect a holistic approach to the promotion of health and wellbeing for all children and are consistent with the United Nations Convention on the Rights of the Child. Children take part in structured lessons and benefit from other activities outwith the classroom such as health related performances, sport taster sessions and outdoor activity. Each child takes part in a minimum of 2 hours weekly quality Physical Education. This will take place both indoors and outdoors and includes links with the community.




### Nurture at Hunter Primary

From time to time, children may have a worry they need to share or talk about. They can speak to an identified adult in school and there are a variety of procedures in place to ensure they can flag up any concerns.

At Hunter Primary we are a Nurturing school. All staff are trained on Nurture principals and pedagogy all with the aim of best supporting all pupils in our school to ultimately get the best out of them and to raise achievement and attainment.

This session we have developed a Nurture classroom in school. This room can be accessed by all children in the school. Pupils who would benefit from a Nurture intervention are identified by their class teacher and/or parent/carer and this is reviewed termly.



### **Social Studies**

Social Studies encompasses many skills and concepts. It includes the children's experiences and participation towards outcomes in historical, geographical, social, political, economic and business contexts. It is through Social Studies children develop their understanding of the world. Children explore a wide range of themes which provide opportunities and the development of a range of investigative, discussion and presentation skills.

Active learning situations encourage children to take ownership of their learning and allow them to experience a very direct learning environment such as their engagement through school visits, enterprise

experiences, local community projects and links with business partners.

Pupils work through a topic approach, concentrating on aspects of a particular theme. Topics studied will depend on the needs/interests of pupils, relevance and external influences e.g. Olympics, World

Cup. No matter the theme, there will be a progression of skills and understanding from Primary 1 to 7. Assessment of key skills and concepts are included in the detailed planning undertaken by the teacher.

### **Expressive Arts and Music Tuition**

The expressive arts include experiences and outcomes in **Art and Design**, **Dance**, **Drama** and **Music**. The Expressive Arts are rich and stimulating, with the capacity to engage and fascinate learners of all ages, interests and levels of skill and achievement.

Our <u>Art</u> programme is drawn from graded lessons from a variety of sources. The programme enables pupils to develop skills to allow them to give expression to their feelings and experiences through a variety of medium. An appreciation of the Great Artists is also covered.

In <u>Music</u>, we have adopted the ABC Music scheme. This programme of music includes singing, listening, making music and appreciation of music. Study of Great Composers also forms part of the music programme.

Instrumental music lessons are offered to children in a number of primary schools across South Lanarkshire Council through our Instrumental Music Service (IMS). Tuition is offered (based on capacity) on a variety of musical instruments, for example brass, strings, percussion, guitar or voice.



Participation in a programme of instrumental music study can help children develop as successful learners, confident individuals, responsible citizens and effective contributors. Children who participate in instrumental music through tuition are often offered opportunities to further develop their playing by participating in extra-curricular activities through bands, orchestras and other ensembles. At Hunter we provide pupils with violin and cello instrumental tuition.

Pupils undertake a variety of <u>Drama</u> activities connected to their topic, reading books and personal



and social development work. Specific skills in drama will be enhanced by the use of a structured scenarios of lesson from Primary 1-7. The series covers a variety of types of drama from improvision, experimental drama as well as performance drama.

<u>Dance</u> skills are taught using a variety of resources and opportunities used to develop expressive skills. Assessment in these areas is mostly by teacher observation of pupil performance on task.

### **Technologies**

The development of technologies in our curriculum relates to the use of Information technologies and other aspects such as craft, design and food technologies. The application of technological skills are an intrinsic aspect of children's learning across the whole curriculum. Through the use of technologies children can develop their creative and entrepreneurial skills. They experience the ability to be adaptable and embrace emerging technologies, an important aspect of personal development as our children will inevitably use technologies and work in areas that currently don't exist.



Our school provides extensive IT resources, including an interactive CTouch board in every class, a fully equipped IT resource area and Wi-Fi link throughout the building. We also have the use of over 15 iPads and 30 Chromebooks all of which are utilised throughout the working day to enhance learning and teaching.

#### **Sciences**



Science is very much a part of our everyday lives. Through science children develop their interest and understanding of, the living, material and physical world. As children progress through the school, they will develop a range of problem solving, enquiry and thinking skills through their investigation of a wide range of themes. They will develop their understanding through a variety of active learning experiences and will develop presentation skills as they present their research to others.

### **Religious and Moral Education**

Religious and Moral Education is taught through topics in class. A programme of work ensures that children study different religions during their time at Hunter Primary. Sometimes RME is taught within a discrete topic such as 'Barmitzvah' while at other times a theme is used to explore what this means within a variety of religions e.g. 'Light' or 'Sacred Places'. As a school, we want to celebrate the cultural diversity of the community we serve. We mark festivals and celebrations from a wide range of religions throughout the year. Personal search, covering such areas as the natural world, relationships and moral values, is dealt with as an integral part of every topic.

Regular assemblies led by teaching staff, pupils and the school Chaplain, allow the whole school to join in simple acts of religious observance.

### Spiritual, Social, Moral and Cultural Values (Religious Observance)

The Scottish Government defines Religious Observance as, "community acts which aim to promote the spiritual development of all members of the school's community and express and celebrate the shared values of the school community". Through Religious Education programmes, we aim to provide opportunities for pupils to visit a variety of religious buildings, meet people from different faiths and reflect on their own beliefs.

Our aim through teaching Religious Education is to make it active, engaging, challenging and thought provoking whilst supporting children in the development of their own set of beliefs and values.

Hunter Primary's school Chaplain is Rev. Sarah Ross, Minister at East Kilbride Moncrieff Parish Church. Sarah will lead some whole school assemblies throughout the year for all pupils. The guidance below provides an overview of the curriculum offered at Hunter Primary. Parents are able to request their child opts out of Religious and Moral Education and / or Religious Observance and can do so by emailing headteacher@hunter-pri.s-lanark.sch.uk.

#### **Opportunities for Religious Observance**

Our Hunter school values of **Happy, Understanding, Nurturing, Truthful, Equal** and **Respectful** promote equality and respect and this forms part of the overall ethos of the school. Throughout the school year there are opportunities for religious observance. At Hunter Primary, religious observance forms part of the RME /PSE curriculum in Broad General Education and encourages learners to reflect on a range of views and form their own. Pupils are encouraged to reflect on the beliefs of others and the world around them through a 'big question' approach and in response to current affairs.

**Discussions:** A range of PSE resources are available in the school and encourage learners to consider religious and moral issues affecting their local community. We support and encourage young people to reflect on their own views and engage critically with others. Our school values promote equality and respect and this forms part of the overall ethos of the school.

**Personal Research**; Through the taught RME curriculum, learners can research the views of others, deepen their understanding of their own views and consider differing viewpoints. There are frequent opportunities to consider conflicting views and moral issues through literature and multimedia resources.

**Partnerships**: Our partnerships in the local community provide opportunities for learners to engage with people whose experiences are far different from their own. We celebrate diversity across the Hunter Primary community and promote tolerance and respect.

**Outdoor learning**: There are frequent opportunities to engage in outdoor learning which provides a natural backdrop for 'big questions' around each person's place in the world and responsibility towards it.

**Assemblies:** Assemblies and discussions promote the opportunity to reflect on views. Assemblies are held weekly at Hunter Primary.

**Sacraments:** We provide equality of opportunity and pupils attending Hunter Primary are offered the opportunity to be supported to complete sacraments within their local parish. Children can access quiet spaces to engage in religious observance during the school day and all individual requests are accommodated.

**Christian Events**: Hunter Primary celebrates Harvest, Christmas and Easter with a focus on exploring and reflecting on views and considering the needs of others (e.g. Collecting for charity, food hampers etc).

### **Rights of Parents / Carers**

Scottish Government Ministers consider that religious observance complements religious education and is an important contribution to pupils' development. It should also have a role in promoting the ethos of a school by bringing pupils together and creating a sense of community. Our practices are based on guidance from the Scottish Government, February 2011 and the Education (Scotland) Act 1980. Religious Observance can take place within classrooms and also during monthly assemblies with our School Chaplain who is Rev. Sarah Ross, the Minister of Moncrieff Parish Church. During these monthly 30 minute assemblies, moral values are explored through drama, media and discussion and a bible story is often used as illustration. It is made clear to pupils that we all have varying beliefs, (religious or not) and that these are all respected.

There is a statutory provision for parents to withdraw children from participation in religious observance. This right of parents' wishes will be respected. The parent/carer should put the request in writing to the Head Teacher.

Where a child is withdrawn from religious observance, schools will make suitable arrangements for the child to participate in a worthwhile alternative activity.

### **Equalities**

Integral to this guidance is the principle of mutual respect. The diversity of belief and tradition provides an ideal context in which pupils can learn about, and so learn from, what is important in the lives of themselves and others. South Lanarkshire's guidance recognises and welcomes diversity and promotes respectful understanding.

Parents may request that their children be permitted to be absent in order to celebrate recognised religious events. Advance notice should be provided to the school when children will be absent. Appropriate requests will be granted and the pupil noted as an authorised absentee in the register

### 8. Assessment and Tracking Progress

Pupil progress is continually assessed by teachers. Assessment is built into the learning to provide the most accurate picture of learning and is based on skills and development and outcomes in line with Curriculum for Excellence levels. It is a way of supporting learning. It helps teachers, learners, parents/carers and others to understand the depth and breadth of learning undertaken so that progress and next steps can be discussed and planned.

Teachers will assess what children know, understand and are able to do within the experiences and outcomes.

The **Experience** describes the learning while the **Outcome** represents what the learning will achieve.

This is often explained, from the pupil's perspective as an 'I can....', 'I am able to....'

Your child's progress is not only based on 'tests' but on the wide range of learning that takes place within the classroom and in different settings outwith the classroom.

Evidence of children and young people's progress and achievements will come from day to day learning and through what they may write, say, make or do. For example, evidence may emerge as a result of children and young people taking part in a presentation, discussion, performance or practical investigation. Evidence could also be a drawing, report, or piece of art work that they have produced. Evidence may be captured as a photograph, video or audio clip as part of a particular learning experience.

- Knowledge and understanding
- Skills
- Attributes and capabilities

Evidence of progress and achievement can be gathered by:

- children and young people through self assessment. They will be encouraged and supported to look at and revisit their own work, to develop a better understanding of what they have learned, and what they need to work on.
- fellow pupils (peers) through peer assessment. Children and young people will be encouraged and supported to work together with others to assess what is good about their work and what needs to be worked on.
- teachers, parents and others who can help identify and support their next steps in learning.

Pupils are fully involved in their learning and made aware of criteria required and next steps in learning. Teachers explain what pupils need to do to improve and pupils are involved in personal target setting. Children are grouped according to working levels for much of their numeracy and literacy work however appropriate support and challenge are provided within these groupings. Continuous review takes place to ensure children are working at the most appropriate level, to their highest standard. Pupils' progress is continually measured against school assessment criteria and CfE Benchmarks and discussed and tracked by senior school leaders on a continual basis.

### 9. Reporting

Hunter Primary School recognise that a good firm partnership between parents, children and schools is the key to a successful education for your child(ren).

Reporting to parents will be ongoing and comprise of a range of activities which can include children presenting their learning, newsletters, and ongoing oral discussions.

We will provide parents with reports so that you can see what your child is doing and how they are progressing. In addition, there will be two parents' meetings which offer you the opportunity to discuss how your child's progressing and how you can contact the school if you wish further information. The school will offer you an appointment time so that you can visit in person to discuss your child's education.



Our 'learner report' will help you to get to know more about the curriculum which each child follows and will describe their strengths, achievements and areas for development so you know what encouragement and support you can give.

We welcome any comments or additional information from parents to help us provide the best possible education for your child.

### 10. Enrolment and Transitions

Enrolment – how to register your child for school.

To register your child for school you should complete our online registration form. This can be done using the South Lanarkshire website.

If you have any difficulty in identifying your catchment school, please email <a href="mailto:Edsuppserv.helpline@southlanarkshire.gov.uk">Edsuppserv.helpline@southlanarkshire.gov.uk</a>

The online registration form will ask you to provide each child's full birth certificate and two pieces of recent official documentation both containing your permanent home address for example a utility bill, council tax statement, housing rent card, child benefit documentation.

Proof of where the child lives may also be needed.

If your child is due to start school in **August 2024**, you can enrol online **from Monday 8 January 2024**. Your catchment school will contact you between Monday 15 to Friday 19 January 2024 to confirm your enrolment.

If your child attends the nursery of your catchment school, please do not assume that they will automatically be transferred. You must register them as normal at the school that is in the catchment area for your home address

If parents want their child to go to another school, they must enrol in the first instance with their catchment school and intimate that they wish to make a placing request. ### **Change of School/Placing Request**

Normally children attend the school in their catchment area. However, there are times when parents may wish their children to go to other schools. If you wish your child to go to another school, then you may make what is known as a 'placing request'. If you live in South Lanarkshire and decide to submit a 'placing request', we are unable to reserve a place in your catchment school until the Council have made a decision on the 'placing request'. Please note if your 'placing request' application is unsuccessful and all places at your catchment school are filled you will be offered a place at the next nearest appropriate South Lanarkshire School.

Please note that if an application for a 'placing request' is successful then school transport is not provided.

If you move outwith your catchment primary school a 'request to remain form' must be completed. If you move outwith your catchment primary, this may affect your right to transfer to the associated Secondary School. Please note the secondary school is determined by the pupil's permanent home address and chosen denomination. If you require further information, please contact Education Support Services on <a href="mailto:education-educ

### **Transition from Nursery to Primary School**

Pupils normally start Primary School if they are 4 years of age by the end of February of that year.

At Hunter Primary, we have an induction programme to ensure all children are well prepared for Primary 1. In the summer term, children are invited in to meet their new teacher and

classmates and to join in with some fun activities.
They will also have the opportunity to meet with their 'big' P.7 buddies who will support them through

Primary 1. Parents/carers will have the opportunity to access some important information about starting school and meet many of the staff from both within and outwith school, who will be involved in their child's education. We do hope you find our P1 Induction Programme both informative and useful in helping you to support your child's learning.



### **Transition from Primary to Secondary School**



Pupils normally transfer from primary to secondary school between the ages of 11½ and 12½, so that they will have the opportunity to complete at least 4 years of secondary education. Arrangements are made by the school to transfer children to the associated secondary school as determined by their home address. Parents of P7 children will be informed of the transfer arrangements made for their child to attend secondary school.

We will also provide you with information at this time on events designed to support P7 children before they move on to secondary school.

In the final term of P.7, there is a full programme of transfer arrangements with Calderglen High School which include parental meetings and pupil visits. These generally take place in May/June. Calderglen High School staff visit the Primary 7 classes and there is a full exchange of information between primary and secondary teachers.

Calderglen High School and all the associated primaries value working together. Curricular opportunities are planned e.g. English department and Science department activities. Opportunities for teamwork and collaboration are encouraged among the pupils.

### Transition between classes/stages

At the time of transition, all teachers receive information about all pupils which includes: reports, attainment levels, working groups and plans, strengths/areas for development, any ASN or pastoral support needs as well as achievements and interests. There is also time allocated to staff to meet to transfer information. All pupils have the opportunity to 'move' to their next class, meet their teacher(s) and the pupils making up the next class.

For pupils with Additional Support Needs, specific arrangements will be put in place to ensure the smooth transition from one class to the next.

### 11. Support for Pupils

### Getting it right for every child.

Getting it right for every child (GIRFEC) supports families by making sure children and young people can receive the right help, at the right time, from the right people. The aim is to help them to grow up feeling loved, safe and respected so that they can realise their full potential.

Most children and young people get all the help and support they need from their parent(s), wider family and community but sometimes, perhaps unexpectedly, they may need a bit of extra help. GIRFEC is a way for families to work in partnership with people who can support them, such as teachers.

If you have any concerns about your child's wellbeing, you can speak to the named person who will work with you to provide support and decide how to move forward. Your school will let you know who this is. It is likely to be the Head Teacher in a primary school and a principal teacher (pupil support) in Secondary.

Every effort is made to identify learning or social, emotional and behavioural difficulties from an early stage. This happens through a staged intervention process which starts at class level and may enlist the support of partner agencies. Strategies will be put in place to support children who have additional support needs. These will be monitored closely and reviewed regularly. Additional Support Needs may be physical, educational or emotional and may be short or long term.

Hunter Primary School Support for Learning guidance provides support for children and young people who require additional help with their learning. Through effective assessment, evaluation and planning pupils with identified needs are given support through a variety of strategies, using individual, group and class approaches to provide opportunities to support learning. Differentiation of content and pace taking account of differing learning styles enables us to set appropriate targets for individual pupils or groups. This is done through, Additional Support Plans or Coordinated Support plans.

In supporting pupils we also have the expertise of specialists who work within the school to support pupils; Specialist Support Teacher, School Support Team, Educational Psychologist, Hearing Impairment Teacher, Visual Impairment Teacher, Behaviour Support Teacher.

South Lanarkshire Education Resources have published a series of leaflets available which cover information for parents and carers about the Additional Support for Learning Acts.

Enquire is funded by the Scottish Government to provide information on the framework for supporting children who require additional support for learning and to encourage positive partnerships between families, schools and local authorities to ensure children get the right support.

### **Attachment Strategy for Education Resources**

#### Attachment – what we do to support children and young people

South Lanarkshire Council Education Resources is committed to improving outcomes for children and young people by creating emotionally supportive learning experiences in our nurseries and schools.

The Education Resources Attachment Strategy supports the action in the 'Getting it Right for Every Child in South Lanarkshire's Children Services Plan 2021-23', following the launch of the Attachment Strategy in 2020, to provide staff training in Attachment and Trauma based practice.

#### What does it set out to do?

The aim of the strategy is to promote better experiences of attachment for South Lanarkshire's children and young people and to ensure that all education practitioners understand the importance of attachment theory and its application and how positive relationships can make a difference to outcomes.

#### How can I find out more?

South Lanarkshire Council Education Resources have published a series of leaflets and posters for establishments and parents/carers which aim to share information on attachment theory and on how this can inform the ways in which we support children and young people.

These are available from schools and on the SLC Staff Learning Centre Sway accessible by teachers and staff.

### 12. School Improvement

The school's agenda for improvement is set out annually in the School Establishment Improvement Plan. Each year priorities are identified for improvement. Staff, parents and pupils are involved in this process on an ongoing basis throughout the previous year. As a staff, we continually review progress with these developments. We also strive to continually improve attainment and achievement each year. In line with Curriculum for Excellence, we ensure a wide range of experiences for our pupils within Literacy, Numeracy and Health & Wellbeing, helping them to develop a variety of skills and employ these skills in various contexts. High standards have continued as methodologies have developed and pupils have become increasingly involved in their learning. The Head Teacher reports annually on progress on these developments, and this can be found on the school website. Achievements are also discussed on an ongoing basis through school newsletters, Parent Council meetings as well as via our school app and website.

Literacy, STEM (Science, Technologies, Engineering and Mathematics), Health and Wellbeing remain high on our school improvement agenda. **Our priorities for 2023-24 session are**:

- Embed updated Writing pedagogy, including planning and assessment to continue to raise attainment in Writing.
- Revise Nurture Principles with the whole school community including the review of taught HWB curriculum.
- To build confidence and expertise in the teaching of STEM activities through engagement in the SSERC initiative (Learning Community Priority)
- Continue to raise attainment in Literacy and Numeracy.

### 13. School policies and practical information

#### Nurserv

All children attending a local authority nursery will be provided with a free lunch. In addition, if your child attends long mornings or afternoons e.g., over 4 hours 30 minutes they will be provided with a 'brunch' or 'afternoon tea'.

Nursery lunches and snacks are based on nutritional requirements from the NHS "Setting the Table" guidance.

Nursery age children will also receive milk and a healthy snack free of charge under the Milk and Healthy Snack scheme 2021. This will be provided by the establishment.

#### **Primary pupils**

Healthy eating is something that the school supports and a range of meals are available at lunchtime that meet the Nutritional Requirements for Food and Drink in Schools (Scotland) Regulations 2020

All primary aged pupils are also offered a free breakfast within their school. The selection available includes cereal, toast, fruit and milk.

For their lunch each day pupils have the option to choose from two hot meal options, a snack option plus a vegan / vegetarian option. These are all served with vegetables or side salad. All **meals** also come with fresh chilled drinking water, salad, seasonal fruit and depending on the day - soup or a dessert.

Milk will be available for those pupils entitled to free school meals through the free school meal eligibility scheme at morning break or lunchtime

### Pupils in:

- Primary 1 5 receive a free school lunch.
- Primary 6 7 meal cost is £2.05.

School lunches and milk can be paid for through your ParentPay account or PayPoint facilities in local shops.

**NB** School Meal prices are reviewed annually and may be subject to change.

#### **Packed Lunches**

These are eaten in the cafeteria also. Lunch boxes are kept in large bags outside the classrooms for children to collect on their way to the cafeteria. Lunch boxes should be collected by the children from the bags outside their classroom at the end of the day. Please ensure your child has items they can open without help. Please clearly label your child's lunchbox as many similarities exist.



All children eat together in the cafeteria, whether taking a school meal or their own packed lunches, water is always available.

#### **Adapted diets**

If your child within Nursery, Primary or Secondary requires a special diet for medical reasons please speak to the school/nursery office who will provide the request form for you to complete. In addition, if you have a cultural diet request for your child please speak to the school/nursery office who will provide you with a request form.

#### **Free School Meals**

Children of parents who receive the following benefits are entitled to a free lunchtime meal for their child

Income Support, Universal Credit (where your take home pay is less than £726 per month), Job Seeker's Allowance (income based), Employment and Support Allowance (income related), Working Tax Credit and Child Tax Credit (where your gross annual income does not exceed £8,717 as assessed by the HM Revenues and Customs), Child Tax Credit Only (where your gross annual income does not exceed £18.725 as assessed by the HM Revenues and Customs) or receive support under Part VI of the Immigration and Asylum Act 1999.

If you are in receipt of Housing Benefit and/or Council Tax Reduction from us there is no need for you to apply online, we will use the information we hold to automatically award free school meals (P6 to S6) and/or school clothing grants (P1 to S6) to eligible families.

We would encourage parents of children who are in receipt of any of the above benefits to take up this opportunity of having a meal provided for their child when they are at school. Arrangements are in place so that children who receive free meals are not singled out and we encourage all children to remain in school at lunch time.

South Lanarkshire Council also offers a **free Breakfast service**. The service runs from **8.15am to 8.45am** each school day. Options include toast, Wheetabix and milk/water.

#### **School uniform**

We ask all parents/carers to support the school by encouraging your child(ren) to adhere to the agreed dress code and the wearing of our school uniform. The wearing of a school uniform helps promote the identity of the school in the local community and helps create an ethos of sharing and pride in the school.

In addition, the wearing of a uniform helps towards increasing the protection of all pupils. The wearing of a uniform helps staff and the pupils to distinguish between who belongs to the school and those who may be visitors. This enables staff to approach and identify visitors more readily and helps in trying to offer a safer environment for pupils and teachers alike.

Equality of opportunity is an important aspect of the life of the school. Any proposals on the dress code and on what constitutes the school uniform will be the subject of discussion with the Parent Council and where appropriate consultation with parents, pupils and staff.

#### There are forms of dress which are unacceptable in all schools such as:

- the wearing of football colours
- clothing with slogans that may cause offence (anti-religious, symbolism or political slogans)
- clothing which advertises alcohol, tobacco or drugs
- clothing which can be deemed unsuitable in terms of health and safety grounds such as shell suits, combat style clothing, dangling earrings, loose fitting clothes particularly in practical classes
- articles of clothing that could be deemed to inflict damage on other pupils or be used by others to do so
- footwear that may damage flooring.
- Accessories which could cause injury to others e.g. false nails

When purchasing school clothing, parents/carers of Hunter Primary children may wish to consider the following items:

- Black or grey trousers/skirt/pinafore
- o White shirt and tie
- Red, white or grey polo top/cardigan (with or without the school badge)
- o A black, grey or red jumper/sweatshirt
- A pair of indoor shoes



# Physical Education (P.E.) Kit

For reasons of hygiene and safety, pupils are asked to wear a gym kit. A polo shirt/tee-shirt and shorts/jogging bottoms should be worn. Tight cycling type shorts are not suitable, being very restrictive during exercises. Training shoes that have been worn outside, are not acceptable for indoor/apparatus work. Pupils are also discouraged from wearing football strips for games or P.E.

Pupils will take part in P.E lessons both indoors and outdoors so we ask that you provide a pair of old trainers and jogging bottoms for outdoor use. P.E kits can be held in school and taken home periodically for washing.

The wearing of jewellery is discouraged at all times for safety reasons, this particularly applies to earrings. All jewellery must be removed for P.E. Fake or Acrylic nails are strictly forbidden in school.

# **Allergies**

A significant number of children and young people in our schools will have allergies and it is important that parents keep the school fully informed on these matters.

Allergies can present in a variety of ways and can occur at any point in a person's life. Symptoms range from mild to severe. Children and young people known to have an allergy with moderate to severe symptoms will likely have a Health Care Plan drawn up by the NHS. This will detail symptoms and appropriate interventions.

It is vital that parents share this information with the school and continue to provide any updated information.

Where symptoms are mild and a Health Care Plan is not in place, parents should still continue to liaise regularly with the school on any new triggers, medications and actions required.

In all cases, our employees need to know your child's symptoms, treatments and any actions required to help prevent exposure to the allergen and minimise the risk of allergic reactions.

Employees in schools will receive training on allergies and will liaise with parents and NHS on any additional specialist training required.

In supporting children and young people with allergies, school employees will operate in accordance with South Lanarkshire Council's Safe Systems of Work / risk assessment and national guidance on the administration of medicines.

#### **Medical and Health Care**

Please inform the school of any medical conditions that affect your child and of any infectious diseases. If a child requires any form of medication during the school day at any time then please contact the school office and complete an Administration of Medicine Form. This must be done by a parent or carer to give consent in order for medication to be administered in school. MEDICATION CANNOT BE ADMINISTERED IN SCHOOL WITHOUT APPROPRIATE ADMINISTRATION.

Pupils with particular health issues are identified in the class register list so that the teacher or replacement teacher can take action in an emergency. Boxes labelled with full details are kept centrally and parents are asked to complete a form giving details and permission to have medication used. Parents should also make a point of discussing any issues with a member of Senior Leadership Team at the beginning of a new session.

The school nurse can also be contacted, through the school office, at any time for advice.

# Please do not send your child to school with foods containing nuts/traces of nuts as we have children with life threatening nut allergies in the school. Accidents in school

Minor accidents are treated by the office staff. Serious accidents may involve contacting the parent or the pupil's Emergency Contact. It is essential that all pupils know who their emergency contact is and that the school records are kept up to date of any change. The school seeks an update on this information at the start of each session.

Serious accidents are recorded on an official form and copies sent to the Education Resources Offices.

Please note that because of Health and Safety rulings, serious cuts can only be treated by placing a clean dressing on the wound. Minor cuts and abrasions are cleaned with mild antiseptic wipes, a lot of plasters and TLC! Please let the office staff know if your child has an allergy to plasters or solution.

When a child takes ill in school and has to be sent home, parents will be contacted to arrange to collect them. We also always inform parents/carers where their child has suffered a bump to the head.

#### **Wet Weather Provision**

At wet intervals, pupils remain in class and Primary 1 to 6 are supervised by monitors from Primary 7. Senior Leaders and support staff also monitor Primary 1 to Primary 7. Wet intervals are brought to pupils' attention by a double ring of the bell, pupils then know to go to their appointed places.

# Information on emergencies

We make every effort to ensure the school remains open during term-time for pupils. However, on occasions circumstances may arise which can affect the school. Schools may be affected by, for example, severe weather, power failures or through any other circumstances that may impact on the school day. In such cases we shall do all we can to let you know if this happens. We shall keep you in touch by telephone, text, where appropriate, letters, web news and through local radio stations particularly if there are prolonged periods of severe weather. The Council's website <a href="https://www.southlanarkshire.gov.uk">www.southlanarkshire.gov.uk</a> will be used to let you know if the school is closed and when it will reopen.

It is important for parents/carers to let the school know of any change to your mobile/home telephone number and change of address.

# Support for parent/carers

## **Clothing grant**

In certain circumstances the Council provides support to parents/carers for the purchase of school wear. This also now includes nursery children aged 3 and 4 years old.

Applications can be made online at <a href="www.southlanarkshire.gov.uk">www.southlanarkshire.gov.uk</a>. If you are required to submit evidence of your Tax Credit income it is important that a copy of this evidence is attached to your online application. Should you require further information or you are unable to submit an application online then please contact the helpline number **0303 123 1011** (option 5).

# **ParentPay**

ParentPay is South Lanarkshire Council's online payment system. This provides a more convenient way for parents to pay online for school meals, educational excursions and other school activities. When you child starts at Hunter Primary, you will receive information to create a secure online account.

#### School transport

South Lanarkshire Council has a policy of providing school transport to primary pupils who live more than one mile by the recognised shortest walking route from their catchment school. This policy is more generous than the law requires. This means that the provision of transport could be reviewed at any time. Parents who consider they are eligible should complete a form online <a href="https://www.southlanarkshire.gov.uk">www.southlanarkshire.gov.uk</a> or contact **0303 123 1023.** These forms should be completed and returned before the end of March for those pupils starting the school in August to enable the appropriate arrangements to be made. Applications may be submitted at any time throughout the year and will be considered by Education Resources.

A privilege transport scheme is operated for mainstream school contracts where a pupil is not entitled to free school transport. Privilege transport will only be granted providing there is spare capacity on an existing school contract and will be from and to designated pick up and drop off points. Privilege transport will not be provided where a service bus is used on the school run. Any spare capacity will be allocated using agreed priorities. #### **Pick-up points**

Where school transport is provided it may be necessary for pupils to walk a certain distance to the vehicle pick-up point. Walking distance in total, including the distance from home to the pick-up point and from the drop-off point to the school in any one direction, will not exceed the authority's distance limit for school transport.

It should be noted that it is the parent's responsibility to ensure their child behaves in a safe and acceptable manner while travelling in and alighting from the vehicle. Misbehaviour can result in your child losing the right to school transport.

Parents are asked to note that South Lanarkshire Council does not provide transport for those pupils who attend school via a placing request.

## Insurance for schools – pupils' personal effects

South Lanarkshire Council is concerned at the level of claims being received for loss or damage to pupils' clothing or personal effects. Parents are asked to note the Council's position in terms of insurance for pupils' personal effects:

## (i) Theft/loss of personal effects

The Council is not liable for the loss or theft of pupils' clothing or personal effects for example mobile phones, tablets etc. and any items are therefore brought into the school at the pupil/parents' own risk.

Parents can assist by ensuring that valuable items and unnecessarily expensive items of clothing are not brought to school.

Teachers and other staff have been advised not to accept custody of any such items.

The same principle applies to musical instruments and other equipment used for activities within the school, which belong to the pupil, but are brought into the school. Parents should be aware that if such equipment is left in school, it is done at the pupil/parents' own risk.

In the case of valuable items such as musical instruments, parents should ensure that these items are covered by their own household insurance.

# (ii) Damage to clothing

The Council is only liable for damage caused to pupils' clothing where the damage has resulted from the negligence of the Council or one of its employees. Claims arising otherwise will not be accepted by the Council's insurers.

# Promoting positive behaviour

It is the responsibility of staff within the school to ensure that parent council members, parents and pupils are involved in the creation of a positive school ethos that encourages good behaviour. Equally, the school whilst trying to promote positive behaviour must support young people should incidents or bullying occur. Parents have a significant role to play in working with the school so that teachers, parents, and pupils know what is expected of them in trying to change the behaviour and attitudes that contribute to bullying behaviour.

Our approach is to create an environment where better behaviour will encourage better learning. The school, along with the support of parents, can work together to create a learning environment which young people can enjoy and feel safe.

Incidents of bullying should be reported to the school immediately so that each alleged incident can be looked at. Together we can work towards creating a safer school for children and staff.

In addition, a guideline (Promoting Positive Relationships and Behaviour) has been produced to support all teaching and support staff and inform them of their roles and responsibilities in respect of dealing with the small number of children and young people who display challenging behaviour. Early

identification is crucial so that intervention can be provided to support children and young people to help them address their issues and concerns. Staff training is provided to help develop the skills needed to respond to and manage challenging behaviour. A wide range of appropriate staff development opportunities has been developed for this purpose.

#### **Child Protection**

All staff in educational establishments in South Lanarkshire Council receive an annual Child Protection update and are required to follow the advice and guidance contained within relevant Education Operating Procedures. They must also complete a mandatory Learn on Line Course "Child Protection in Education".

South Lanarkshire's children's services partnership works together to support children, young people and their families so that children grow up in communities where they are safe, healthy, active, achieving, respected, responsible and included, and have the opportunity to achieve their full potential. They are committed to continuously improve our services to ensure children, young people and their families get the right support at the right time.

Sometimes children and young people need additional help to make sure that they are "cared for and protected from abuse and harm in a safe environment in which their rights are respected" (CPC South Lanarkshire Child Protection shared vision). The Child Protection Committee has the overarching responsibility to ensure that agencies individually and collectively work to protect children and young people as effectively as possible.

All staff have a responsibility to report any suspicions that a child has been abused or is at risk of harm, abuse, or neglect. Robust procedures and guidance are in place to support education staff to:

- be alert to signs that a child may be experiencing risks to their wellbeing,
- report concerns to the head of establishment or the child protection coordinator without delay.
- be actively engaged in support and protection and development of wellbeing.

If you would like more information, or have a concern of a child protection nature, please contact the head of the educational establishment which your child attends.

# General Data Protection Regulation as supplemented by the Data Protection Act 2018 (GDPR)

Information on pupils, parents and guardians is held by the school to enable the teaching, registration and assessment of pupils as well as associated administrative duties. The information is stored and used as per the requirements of the GDPR, with South Lanarkshire Council defined as the data controller. The Council have established a data protection policy that applies to all of its school. Education Resources has also prepared a privacy notice (below) which sets out how we will deal with personal information as part of our statutory function as an education authority. ## **Privacy Notice**

#### Introduction

In line with the General Data Protection Regulation (GDPR) we have produced this privacy notice to inform you how we deal with personal information as part of our statutory function as an education authority.

The Council has a legal obligation to deliver effective education services to children, young people and adult learners in South Lanarkshire. In order to do this we need to collect personal information about children, young people and their families so that we can help them to learn and keep them safe.

# **Using your personal information**

The Council is a "controller" of the personal information you provide when enrolling for a nursery or school, applying for an education service or participating in groups or activities provided by Education Resources.

# Information we collect from you about you and your child at enrolment

When you enrol for a nursery or school, we ask for the following information:

- parent/carer contact details (name, address, phone, email);
- the child's name, date of birth, gender and address;
- information about medical conditions, additional support needs, religion and ethnicity;
- any information you may wish to provide about family circumstances.

## Information we collect at other times

We will also collect information at other times such as when you apply for a benefit, request a services or other support. We will provide an additional privacy notice at these times.

- If you apply for an education service or benefit, such as school transport, free school meals, clothing grant, placing request or EMA, we will also ask for personal information as set out above. We will also ask for information about your income for education benefits applications.
- If you make a request for additional support such as an educational psychologist or other support for learning we will ask for more detailed information to allow us to provide the most appropriate support for your family. This may include information about family circumstances or medical conditions.
- If there are concerns about your child's wellbeing and/or your child has needs that may require
  additional support, we will wish to work with you to collect and consider information to enable us
  to help you get the right support at the right time in line with the Getting it right for every child
  approach.

We require this information to ensure that children and young people are educated appropriately, supported, and that we take account of their health and wellbeing. We will also ask you to update this information annually and to tell us when there are changes to your details.

#### Information that we collect from other sources

As an education authority and as part of our statutory function in accordance with our legal obligations, we receive information from other sources such as the SQA, the NHS or Social Work about you or your child, this includes:

- exam results and assessment information:
- information about health, wellbeing or child protection.

# Why do we need this information?

We need this information so the Council can ensure it is delivering education services appropriately to all learners:

- for the education of children, young people and adult learners;
- for teaching, enrolment and assessment purposes and to monitor the educational progress of children, young people and adult learners;
- to keep children and young people safe and provide guidance services in school;
- to identify where additional support is needed to help children, young people and adult learners with their learning;
- to maintain records of attendance, absence and behaviour of children and young people (including exclusions);
- to support children and young people moving on each year from nursery to primary, primary to secondary and when they move or leave school;
- to help us develop and improve education services provided for young people, adult learners or families
- In accordance with our legitimate interests as an education authority we will also use your information to create statistical reports.

## We will share your information with:

As an education authority and as part of our statutory function in accordance with our legal obligations we will share information with other bodies or parts of the Council, including:

- The Scottish Government and bodies such as Education Scotland, Scottish Qualifications Authority, Skills Development Scotland and other organisations that support children and young people's learning;
- Other parts of the Council when required for services such as school meals, school transport, education benefits and with Social work in connection with any child protection concerns we become aware of:
- The NHS, to support health initiatives in accordance with the legal obligation on the Council in terms of section 39(3) of the National Health Service (Scotland Act 1978;
- South Lanarkshire Leisure and Culture Limited, where children and young people are participating in sports and leisure activities;
- Other schools/local authorities if a child moves or transfers to another school the Council has an obligation to pass on information with regards to pupil records to the new school/local authority.

You have the right to access your personal information as well as the rights of rectification, erasure, restriction and the right to object.
